We provided each family with a pack of dry rations, amounting to Rs. 2,000 per pack, which we believe would be adequate for 1.5 to 2 weeks. The pack consisted of dry rations such as rice, dhal, cooking oil, soya, soap, tea, sugar, milk powder and biscuits for the children.


